- A. Misti Marsh, St. Louis VA Region Director briefed:
 - 1. COVID cases are decreasing in the St. Louis area
 - 2. Several Presumptive Conditions being added to Gulf War
 - 3. Hiring 2,000 Claims Processors in order to meet backlog demand
 - 4. Currently have 178 VA vacancies
 - 5. 250,000 claim backlog with 625,000 pending claims
- B. John Cochran VAMC, St. Louis, Director, Keith Repko briefed:
 - 1. Saw 6,000 Veterans last year than pre-COVID
 - 2. Received 90% Customer Satisfaction
 - 3. Received 95.4% on Quality of Service

- C. MAVO Vice-Chairman, Troy Williams briefed:
 - Biggest concern was long-term funding the Missouri Veterans Commission
 - 2. Need to Fully Fund MVC
