    - Lake Ozark CBOC is also growing

- John J. Pershing VAMC, Poplar Bluff, Associate Director briefed:
  - o There is a lot of COVID Vaccine hesitancy
  - o CBOC is expanding ER capabilities
  - Many major updates in infrastructure through facilities
- John Cochran VAMC St. Louis, Chief of Staff briefed:

  - Will be keeping a lot of the telehealth initiatives
  - o 21.000 Veterans vaccinated
