2013 Missouri Woman Veteran of the Year



The 2013 Missouri Woman Veteran of the year will be announced at the Women Veterans Luncheon on September 28th in Jefferson City. Please submit your nominations for this commendable award. Applications must be received or postmarked by September 6, 2013. The winner selected will receive special treatment at the luncheon and be recognized in her home town newspaper. This award will be given to a Missouri Woman Veteran who has compiled a record of exemplary service as a Military Service Member, Veteran and as a Citizen in her community. Nominations may be submitted by a nominee or the Veteran herself. The application is attached to this newsletter or can be found at www.mvc.dps.mo.gov/docs/women/womenvet-nomination.pdf. I know there are many Women Veterans in the State of Missouri that are very deserving of being recognized for this award.

Flag Day



Flag Day is celebrated every year on June 14th. It commemorates the adoption of the flag of the United States, which happened that day by resolution of the Second Continental Congress in 1777. In 1916, President Woodrow Wilson issued a proclamation that officially established June 14th as Flag Day. The day commemorates the adoption of the Stars and Stripes as the official flag of the United States. In August 1949, National Flag Day was established by an Act of Congress. Although today, many citizens don't need to be reminded to fly the flag as the recent acts of terrorism has reminded us all what the flag stands for, freedom.

Flag Etiquette

The U.S. flag should be displayed from sunrise to sunset, unless it is well lit during darkness

XOn a stage, the U.S. Flag should always be placed behind the speaker and to their right

When hanging the U.S. Flag vertically or horizontally from a wall or window, the canton, or union, should be at the top right of the flag. When you face the flag, it should be on your left

On Memorial Day, the U.S. Flag is flown at half staff until noon, and then raised until sunset

The President of the U.S., governors and limited other government officials may direct the U.S. Flag to be flown at half staff

The U.S. Flag should not be allowed to touch the ground, but if it does, you are not required to destroy it as long as it's still suitable for display

KIt is acceptable to wash or dry clean a U.S. Flag to keep it in good shape

*Only all-weather U.S. Flags made of non-absorbent material should be displayed during bad weather

When a U.S. Flag has served its life, it should be destroyed, preferably by burning. Many American Legion posts have special ceremonies on Flag Day.

Never use a U.S. Flag to cover a statue or monument or drape the flag over the hood, top, sides or back of a vehicle, train or boat

The U.S. Flag should not be used as wearing apparel, including costumes or athletic uniforms, bedding or drapery

The U.S. Flag and the Missouri state flag are flown at half staff on all government buildings for one full day as determined by the Governor, whenever a Missouri resident and member of the military forces is killed in the line of duty

Every schoolhouse should display the U.S. Flag during school days

The U.S. Flag should never be used for advertising purposes

When I was only 19 years old I had a "Rosie the Riveter" kind of job as I was a sheet metal worker. At the age of 22 I joined the Army in September 1946. It was a duty I felt compelled to do with some influences from my older brothers, Fred who served in the Army and Glen who served

in the Navy. My job was a Statistical Technician. I was discharged from the Army in 1948 and immediately (the next day) I joined the Air Force. I was paid \$100 to re-enlist. I was stationed at Lowry AFB in Denver, Colorado and Offutt AFB in Omaha, Nebraska. My most memorable time of my service was when I was stationed in DC and I worked in the Pentagon. I earned several medals to include the Good Conduct, Victory Ribbon, National Defense Medal and Good Conduct Medal Clasp. I served until March 1954. We were patriotic back then, and if I could do something, I wanted to

do it. I was happy to be there. I was proud and still am very proud of saying I served. Because of my service I have been able to utilize my Veterans benefits that have really assisted me in my life. Today, I enjoy fellowshipping with other Veterans and spending time with my dog.



Wilma Bergjans

I am originally from Missouri and I joined the Army (WAC) in March 1945. My sister, Thelma (who is now deceased) and I joined together, we were ready to leave home and help our Country. I went to boot camp in Oglethorp, Georgia. While I was in Georgia, President Roosevelt died. There was a big parade to

honor the President, and I can still see and hear the planes fly over. After boot camp and training I was stationed at O'Riley Hospital in Springfield, Missouri as a Surgical Tech 861. One of my duties was to give shots to the patients. The boys' arms were so strong from their Army duties, it was hard to give them a shot as they had no fat in their arms. One was so muscular the needle broke off in his arm. I was scared and went and found my supervisor, but the soldier didn't mind, I think he liked all the attention he was getting. While serving in the Army, I enjoyed being with the people, helping the boys and my Country. We had a lot of laughter together and I knew I was doing a good thing. I was honorably discharged in October 1946 and moved to St. Louis, Missouri where I met my husband Greg. We have three daughters and I have nine grandchildren and two great-grandchildren. After I came home from serving I re-opened my beauty shop as I was

a cosmetologist in my civilian job. I reside in Missouri and I enjoy playing bingo and pokeno. I especially like to knit and crochet as I make items for a charity called "Newborns in Need". My current picture is me celebrating my 97th birthday. I now reside in an Assisted Living facility with help from the VA.



Wauneen Rucker

My mom passed away when I was 9; so it was decided that I would reside with my grandparents. There was a rule; I had a lifetime to be an adult, so school was my job. After hard work, I was inducted into the National Honor Society as a Sophomore. My Senior year, I attended college 1/2 of the day. After

graduation I entered college as a Sophomore. I became very TIRED of school! One day while out with friends I walked passed a Marine Corps recruiting office. Immediately, I was drawn to the crisp looking uniforms. I stopped in, walked directly to the recruiter and frankly told him that I wanted to become a Marine. At first the recruiter "kind of" chuckled me off because I was so petite. After realizing that I was serious, I signed up. Once I completed "boot camp" I trained at Camp Pendleton and I was stationed there. Two weeks after reporting to my duty station, a life changing thing happened. A very distinguished, "full bird" Colonel walked in the office and requested that I help him with a project. Following orders, I

did. At the end of the project, I was informed that I would become the personal aide to Col. James S. May - Sr. Staff Judge Advocate for Marine Corps Base. Col. May was second in command of Base Gen. Robert Haebel. The rest is history!!!



Elizabeth Ann McKie

After high school I joined the Women's Army Corps, the WACS. My training included members from all branches of service. There were 40 men for every three women. I remember the women were treated like a big joke, with the men

quacking like ducks when we passed by. But the women took the training seriously. At that time artillery training was optional for women. Most of the women went onto serve as nurses in Vietnam with some going to China. I was stationed in Maryland near Washington, DC, getting supplies to the troops in Vietnam as well as relaying messages to and from the Vietnam area. My office was in a cave in the mountains outside of Washington that was listed as a secret hideout for government workers who may need to take shelter. It was set up as a communications center and furnished with supplies for thousands of people in case of attack. We were taken to the underground by bus and never told its exact location. Years later the Top Secret restriction was lifted and I saw pictures of the area in a newspaper. It has since been replaced with another location, also Top Secret. One day while traveling by bus to the underground, I met a soldier there, we started a friendship that has now resulted into over a 30 year marriage. I proudly served 1 year, 1 month and 1 day as I found out I was expecting and in the 1960's

women were honorably discharged if they were pregnant. I recently retired after working over 30 years at the Kansas City VA. I look forward to spending time with my family and traveling.

Q. I am an 87 year old female Veteran; I lost my husband three years ago. I can still manage some things on my own, but there are days when I would like a little assistance with my day-to-day activities. I am not ready to reside in a Nursing Home, what other options are there for me as a female Veteran?

A. This is a great question. There are several options you can look at if you are not ready to reside in a Nursing Home. These options consist of:

- 1. In-Home Health Care
- 2. Community Services
- 3. Supportive Housing Programs
- 4. Assisted Living
- 5. Retirement Community
- 6. Respite Care
- 7. Adult Day Health Care

I would recommend contacting your local Veterans Service Officer (VSO) for a list of these programs in your community. You may also qualify for a Non-Service Connected Pension to off-set some of these costs. Please call 573-751-3779 for the closest VSO in your area. If you're not already enrolled in VA Health Care I would recommend that as well; as there is free services available to assist you through the VA. Also, keep in mind Missouri Veterans Commission has seven Veterans Homes in the state of Missouri that you may be eligible to reside in as well when you feel you are ready for that transition.
