On September 28th, Marge Scott, 2012's Missouri Woman Veteran of the Year will pass the crown to the 2013 Missouri Woman Veteran of the year. The winner selected will be honored at the Women Veterans Luncheon and Expo on September 28th at the Capital Plaza in Jefferson City and she will also be recognized in her home town newspaper. Nominations for the 2013 Missouri Woman Veteran of the year must be received or postmarked by September 6, 2013. This award will be given to a Woman Veteran who has compiled a record of exemplary service as a Military Service Member, Veteran and as a Citizen in her community. Tell 3 Women—Pay Forward the Legacy is the latest initiative by the Women in Military Service for America (WIMSA) Memorial Foundation to help the nation's 2.5 million Women Veterans take their rightful place in history. The campaign ask each of us to embrace women's rich legacy of service and to cultivate and pass it forward by introducing three Women Veterans to the memorial and encouraging them to register.

The Foundation's annual goal is 10,000 registrations per year. In Brigadier General Vaught's latest letter to all WIMSA members, supporters, and friends she spoke of the fact that the Memorial has surpassed 250,000 registered women Veterans. She says "If you aren't registered yet, I hope you'll do so now and take your place in the pantheon of women's service and be a part of the second 250,000 members. Or, if you know of a servicewoman, past or present, help her get registered so that she too takes her place in history."



VA Launches a Women Veterans Hotline

Women Veterans are currently one of the fastest growing population of Veterans. Over the past decade, the number of women using VA health care has more than doubled, from nearly 160,000 to more than 360,000 in 2012. Women now make up 15 percent of active duty and 18 percent of Guard/Reserves service members. Based on the upward trend of women in all branches of service, the number of women Veterans and female VA users is expected to double again in the next decade. The Veterans Administration has started a Women Veterans Hotline **1-855-VA-WOMEN** (1-855-829-6636). This is an incoming call center that receives and responds to questions from women Veterans, their families, and caregivers across the nation about available VA services and resources. This is yet another great VA benefit and another way of recognizing Women Veterans.

Saluting Our Women in Uniform

I came from a long line of military on my father's side of my family. Dad was a Navy man and so was his father. Listening to him telling of his war stories and listening to current war stories in the news, inspired me to enlist in the Navy during the Vietnam War era. I believed it was the most patriotic and

inspiring thing to do in 1968. Boot-camp in the Navy was much better of an experience than my first and only duty station in Pensacola, FL because there wasn't any teasing of women as WAVES-to ride. Boot camp in Maryland was a place where I felt that I was a part of something, even though the daily duties were harder than I thought it would be. Still, I felt and acted like someone to be proud of in a time of turmoil in our Country. Pensacola was where I trained to become an aviation storekeeper. In this position I was among all Navy service men in the "Material Shop" where airplane and jet

parts were ordered. I proudly served a year, ten months and 17 days. I had to leave the Navy because in 1969 I married a Navy serviceman and became pregnant. I was honorably discharged and began my life as a mother and I went to college to become a Special Education Teacher.



Mary (Kathleen) Fennewald



I joined the Navy in 1944 and went to Hunter College in Bronx, New York for six weeks of boot camp. After boot camp I was sent to Sampson, New York for eight weeks of postal school. After my schooling I went on a fourday train ride to San Francisco, California to work my assigned job in the Fleet Post Office.

My job was to sort the mail, package and code it so the mail would be delivered to the correct naval ship in the Pacific. I worked for seven days and had the eighth day off. I had a great friendship with my roommate and we got along really well. We enjoyed going to listen to the bands and going to the movies. I decided to get out of the military in 1946 because I wanted to start a family. I was discharged at the rank of a MaM2c (Mailman 2nd Class). I received several medals while in the Navy to include: an Honorable Service Lapel Button, Honorable Discharge Emblem and an Honorable Discharge Pin. I returned to Missouri and

met my husband and we had a family and we raised cattle and crops. Today I enjoy sewing, quilting, playing bingo and going on outings with my friends, family and fellow Veterans. I am a proud Veteran and happy to be using my VA benefits for which I am eligible for.



Bertha Johnson



I was born in Brooklyn, NY and attended an all girls Catholic School. After I graduated from high school, I worked as an AT&T operator in Brooklyn. A high school friend and I decided to join the USMC as the war was in full swing. I joined the Corps on March 8, 1943. After my schooling I was stationed at the USMC

headquarters in Washington, D.C. While working there I met my future husband, Leonard Johnson. We were married on March 15, 1944. I was discharged in August 1944 at the rank of Sergeant. After the war we moved to Springfield, MO. In 1951 Leonard was activated for the Korean War and sent to Camp Pendleton, CA. I packed up the two kids and a dog in our 1948 Pontiac and traveled to California on Route 66. It was quite an adventure. We lived on Camp Pendleton in base housing for a year and returned to Springfield after he was deactivated. I went to nursing school at St. John's and became an LPN. I worked there at the hospital in the

pediatric ward and in a few doctor's offices. In the 1960's the family bought a house boat and spent many happy hours on the weekends fishing and relaxing. I retired from working and became a stay at home wife. I am using my VA benefits and I'm proud to have served.



Normandy Myers



I grew up in Zalma, Missouri and I am the oldest of two children. My brother also served in the military. After high school I attended one year at Southeast Missouri State University. I then went to pursue my degree in nursing from Jewish Hospital in

St. Louis. I served in the Navy from 1947 to 1949, joined the Navy Reserves from 1949 to 1951, and then re-entered the Navy from 1951 to 1953. I did not attend boot camp, instead I went into the Navy Nurse Corp. after passing the State Boards. I was stationed at St. Albans, New York on Long Island for 1 ½ years. I was awarded the Korean War Medal. My job in the military was as a nurse/R.N., with the rank of Lieutenant. My favorite memories during the military relate to being in St. Albans because I got to go to New York City all the time – to places like Carnagie Hall, Radio City Music Hall, and Rockefeller Center. I decided to get out of the military because I wanted something different. I was a nurse at the VA Hospitals in St. Albans, New York

and Portsmouth, Virginia. Today I enjoy socializing with my friends and arranging flowers. I am currently using my VA benefits and I am glad to have them.





Q. My Mother passed away in May of this year. She was a proud Veteran and served during WWII. I ordered her marker but is there any other recognition I could have as a keepsake for the family to remember her service to our Country?

 \mathcal{A} . Yes, there is a Presidential Memorial Certificate that is mailed to the next of kin signed by the current President to honor the memory of honorably discharged Veterans. This program was initiated in March 1962 by President John F. Kennedy and has been continued by all the subsequent Presidents. I have attached the link for the form as it gives the address to mail a <u>copy</u> of the Veterans Discharge, Death Certificate along with the form. Also, here is an example of what the Presidential Memorial Certificate looks like; it is a distinguished way to remember our Veterans.

Fascinating Facts

Compensation benefits - In FY 2012, 300,937 Women Veterans received compensation benefits – an 8% increase from 2011.

Pension benefits- In FY 2012, 12,594 Women Veterans received pension benefits – a 3% increase from 2011.

Home Loan Guaranty- In FY 2012, 56,302 Women Veterans were guaranteed loans totaling \$12.5 billion – that's a 42% increase from 2011.

Education- In FY 2012, 106,953 Women Veterans accessed education benefits—a 17% increase from 2011.

VRAP (Veterans Retraining Assistance Program)-In FY 2012, 14,939 Women Veterans applied for the benefit (16.8% of total applicants).

Veterans Group Life Insurance (VGLI)-In FY 2012, 55,550 VGLI policies belonged to Women Veterans a 3% increase from 2011.

Service members Group Life Insurance Traumatic Injury Protection (TSGLI)-In FY 2012, 119 Female Service members received a TSGLI benefit – a 35% increase from 2011.

According to the VA the Women Veterans population in Missouri is 44,894
