Veterans Returning into the Workforce

Veterans returning back into the civilian life are having difficulty trying to find employment. Unfortunately, women Veterans are having a more difficult time finding employment than their male counterparts. This is due to many factors that are affecting women who served. The unemployment rate has steadily increased in recent years. The average unemployment rate in 2007 for the Gulf II women Veterans was 9.3% and males were only 5.6%. More recently the unemployment rate has increased to 16.6% for women Veterans and is only 8.6% for male Veterans.

More women are deploying today than ever in history. A large number of these women in the service are single mothers and had to leave their children with family or friends while they are deployed. When returning and reentering into the civilian life most women's aspiration are to reunite with their family, find a safe place for her and her children to live and find a secure job.

On November 21, 2011 President Obama signed into law Returning Heroes and Wounded Warrior Tax Credits.

The Returning Heroes Tax Credit is a new hiring tax credit that will provide an incentive for businesses to hire unemployed veterans.

- <u>Short-term unemployed:</u> A new credit of 40 percent of the first \$6,000 of wages (up to \$2,400) for employers who hire veterans who have been unemployed at least 4 weeks.
- <u>Long-term unemployed:</u> A new credit of 40 percent of the first \$14,000 of wages (up to \$5,600) for employers who hire veterans who have been unemployed longer than 6 months.

The Wounded Warrior Tax Credit will double the existing tax credit for long-term unemployed veterans with service-connected disabilities.

- Maintain the existing Work Opportunity Tax Credit for veterans with service-connected disabilities (currently the maximum is \$4,800).
- A new credit of 40 percent of the first \$24,000 of wages (up to \$9,600) for firms that hire veterans with service-connected disabilities who have been unemployed longer than 6 months.

These two Tax Credits should assist Veterans in finding employment and helping them transition back into civilian life. Another piece of information is to remember those skills you learned in the military that you can use in the civilian sector such as: leadership, time management, attention to detail and organizational skills.

First Woman to lead U.S. Coast Guard Academy

Attention on Deck! On June 3rd, 2011 - Rear Admiral Sandra Stosz became the first woman to lead the U.S. Coast Guard Academy and the first to head any of the military services' academies. Stosz was installed as 40th superintendent of the New London, Conn., campus, replacing Rear Adm. J. Scott Burhoe, who led the school since 2007. The native of Takoma Park, Md., graduated from the academy in 1982, the third class to include women. "We've come a long way and I'm proud to be a role model," said Stosz. "But this really is part of a natural progression." Rear Adm. I served twenty years with the USAF. I entered the service and worked in Signals Intelligence in Italy. I ate everything I could. My next assignment was to Hawaii. Nice. I

My next assignment was Wiesbaden Germany. I worked with the Executive Health Program along with the hostages repatriated from Lebanon. I learned from these men what it means to be alone and not know what your future may be. I worked with the NASA Space shuttle Program. The overseas abort sights we manned were in Africa. Words cannot describe the differences between the countries of our world. My final base was Eglin Air Force Base in Florida. Here I worked with a team of four to develop a new process for military examinations. This program is now

DOD wide and is known as PHA. My nineteenth year I was diagnosed with brain cancer. My treatment at Wilford Hall Medical Center was outstanding. What they did then makes it possible for me to write this now.

During my tour there I worked as an Officer Evaluation Clerk, I also attended PLDC in Bad Tolz, Germany. In my 11th month I was in small arms school in Vilseck, Germany. It was a challenge, seems I always forgot where 1 piece went when putting the weapon back together. My other tours included tours of Germany, U.S, and Korea. I worked in a merit of positions from Bn to Bde S1, in all HR sections. My awards include MSMx4; ARCOMx3; AAMx5; Army Good Conduct MDLx7, NDSMx2; Terrorism Svc. MDL; Korea Defense Svc MDL; Overseas Service Ribbonx4; NCO Prof Dev ribbonx3 and the Army Service Ribbon. I am married and have 2

- Q. What is the proper protocol for a Veteran when the National Anthem is being played at an event or the colors are being presented?
- A. According to Public Law 110-181 Members of the Armed Forces and Veterans who are present but not in uniform may render the military salute. All other persons present should face the flag and stand at attention with their right hand over the heart, or if applicable, remove their headdress with their right hand and hold it at the left shoulder, the hand being over the heart.
- Q. Is there a document/piece of paper/anything that a woman Veteran can carry to show we truly ARE a veteran short of a copy of our DD-214?
- A. The only identification at this time for a Missouri Veteran to use to prove they are a Veteran is their DD214, Retired Military ID card or ID Card that is issued if they are enrolled in the VA Health Care. I encourage all Veterans to enroll in VA Health Care.
- Q. Since Social Security is receiving a raise in 2012, does that mean the VA will be increasing their rates also?
- A. Yes, you will see a 3.6% increase in your rates starting Jaunary 1, 2012 if you are a service-connected Veteran, who's in receipt of compensation, or nonservice connected pension, or a surviving spouse of a Veteran who's in receipt of death pension or Dependency and Indemnity Compensation (DIC). VA Statistics for Service Connected Compensation in Missouri

I understand and sympathize that many Veterans are frustrated with the VA system when they are in an appeal status on their service connected compensation. I recently attended a seminar given by the VA and they shared the statistics on how busy the regional VA office is in St. Louis, Missouri. Below is an estimate on how many Appeals and Notice of Disagreements are being handled in just the state of Missouri.

- 175 Appeal Cases Pending for the Traveling Board
- 6,500 Appeals in the State of Missouri and there's only seven Decision Review Officers working these claims
- 595 Cases Pending in Missouri for the Board of Veterans Affairs
- 4,251 Notice of Disagreements pending in St. Louis
- 2,064 Form 9's pending in St. Louis
- An appeal can take up to two years to be settled
